

# BURKINA FASO : A SAHELIAN COUNTRY IN THE MIDDLE OF WEST AFRICA

With its geographical location, Burkina Faso is the crossroads of West Africa. Its capital city Ouagadougou is only 2 hours flight from each of the capital cities of the other UEMOA countries.

The 3rd best average growth rate between 2000 and 2007 (+6.1%) of the 14 countries in Sub-Saharan Africa in the CFA zone (BCEAO and BEAC) after Equatorial Guinea and Chad (IMF, April 2008).

A stable economy (rated « B » in the short and long term by Standards & Poor's) (Report on the CFA zone, Bank of France, August 2008). The 2nd country in terms of economic performance out of 38 African countries, members of the African Development Bank, according to criteria including quality of the policies implemented, public institutions, governance and also performance of portfolio financed by AfDB (African Development Bank, March 2009). The 1st country in the UEMOA zone in 2007 as far as private investment growth is concerned (+ 9%) (French Cooperation Agency, April 2007).

The 6th best country in the world in terms of reforms and the 2nd in Africa in terms of business opportunities offered to business people (World Bank, Report on « Doing business 2009 », September 2008). An economy listed 8th in 2009, out of 46 African countries in Sub-Saharan, according to the Economic Liberties Index of the Heritage Foundation and Wall Street Journal (Heritage Foundation, January 2009).

- Ranch of Nazinga : admire the numerous mammals of the African fauna.

- Granite site of Laongo : admire the masterpieces carved rocks by artists from all over the world.



# BURKINA FASO: PAÍS SAHELIANO EN EL CORAZÓN DE ÁFRICA OCCIDENTAL

Gracias a su posición geográfica, Burkina Faso es el eje central de África occidental. Su capital, Ouagadougou, se encuentra a 2 horas de vuelo de las capitales de los países del espacio UEMOA.

La tasa de crecimiento medio, entre 2000 y 2007, de Burkina Faso (+6,1%) ha sido la tercera más elevada de los 14 países de zona franco (BCEAO y BEAC), después de Guinea Ecuatorial y Chad (fuente: FMI, abril 2008).

Burkina Faso tiene una economía estable, calificada de «B» a corto y largo plazo, por la Agencia Standard & Poor's (fuente: Informe zona franco, Banco de Francia, agosto 2008). Burkina Faso es la segunda economía de los 38 países africanos miembros del Banco Africano de Desarrollo (BAD), en calidad de políticas implementadas, instituciones públicas, gobernanza, así como por el éxito de los proyectos financiados por el BAD (fuente: BAD, marzo 2009). Además, es el primer país de la zona UEMOA en crecimiento de inversión privada en 2007 (+9%) (fuente: Agencia Francesa de Desarrollo, abril 2007).

Burkina es también la sexta economía más reformadora del mundo y la segunda en África, en facilidad para hacer negocios (fuente: Banco Mundial, Informe «Doing business 2009», septiembre 2008). Ocupa el octavo lugar, en 2009, de los 46 países situados al sur del Sahara, según el índice de libertad económica, de la Fundación Heritage y el Wall Street Journal (fuente: Heritage Foundation, enero 2009).




