1	Application to be addressed to the Uzbek MOD requesting a permission for special goods transition and indicating purpose of transportation, number of cargo items, planned terms, points of entry to/exit from Uzbekistan, transport means used, information on goods dispatch and destination places, consigner's title, consignee's title, as well as planned itinerary through the countries concerned	To be prepared in the free format by consigner
2	Certificate to be issued in the country of origin of the special goods	To be issued by the Standardization Authority of the consigner state for the goods conveyed
3	Contract/agreement for supply of goods	The contract/agreement for supply of goods to be concluded between consigner and consignee
4	Transportation schedule for the transition of dangerous cargo by separate lots	To be prepared by consigner
5	Information on goods nature as per the Commodity List of the Foreign Economic Activity of Uzbekistan and the UN Commodity List	To be prepared by consigner in association with the Agency for Foreign Economic Activity of the applicant country
6	Classified code for the substance	To be issued by the Standardization Authority of the consigner state
7	Aggregative state	Information to be provided by consigner
8	Dangerous properties	Information to be provided by consigner
9	A document to confirm the availability of insurance and other guarantees for separate goods	Insurance policy, bank guarantee or other format specified by legislation
10	Commitment to compensate for damage/injury/harm to lives or health of people, environment and security of the Republic of Uzbekistan	To be prepared by consigner in the free format

11	Commitment by consigner and consignee not to re-address or re-export goods under the terms being unfavorable to Uzbekistan	To be prepared jointly by consigner and consignee in the free format
12	Request for escort by the internal affairs agencies <i>Note: Escort services provided by the subdivisions of the Uzbek Ministry of Internal Affairs for the special goods transported by motorcar vehicles through Uzbekistan shall be paid for separately by an applicant</i>	To be prepared in the free format and submitted by consigner to the Uzbek Ministry of Internal Affairs
13	Certificate on permission for transportation required for vehicles	To be issued by the Ministry of Internal Affairs of consigner state

- Note: 1. Documents required for the issue of permission for transition of special goods shall be submitted 35 days before the month planned for transportation.
2. Period for consideration of the documents pertinent to transition through the territory of Uzbekistan shall be 30 days from the submission date.
