PRELIMINARY CONCEPT NOTE

ABOUT "INVEST IN EAST"

The Chief Ministry of the Eastern Province is taking a number of initiatives to attract Foreign Direct Investment including Investments from the Diaspora community into the Eastern Province. Towards this the Ministry is proposing to organize for the second time, a special Investment Promotion Forum for the Eastern Province on 28th of January 2016. It is proposed to be organised as a collaborative initiative with the Ministries and Agencies mandated with Investment Promotion and Economic Development of the Central Government. We also propose this Forum to be organised on an annual basis in order to achieve sustained investment into the Eastern Province of Sri Lanka.

The theme for the Forum is "Creating Conducive Environment for Investments and Employment Creation" especially in the post conflict development context. The Forum is expected to attract over 300 potential investors from around the world. Speakers at this prestigious gathering will include Government officials, captains of Industry, tourism operators, corporate bodies, business associations, financiers and many other interest groups and individuals.

GOAL

The objective is the Presentation of investment opportunities of the Eastern Region of Sri Lanka. The event is aimed to improve the investment climate and to further encourage the inflow of domestic and foreign investments into the economy of the region, the formation and promotion of brand "Invest in East" to the world, particularly to the Sri Lankan Diaspora is also a key objective.
