





We cordially invite you to the 12th Sarajevo Business Forum 2023, which will be held in Sarajevo (Hotel Hills Ilidža), from May 18 to 19, 2023

The 12th Sarajevo Business Forum, a prestigious and recognizable platform for business networking and researching investment and business opportunities in the countries of Southeast Europe, is organized aiming to boost economic development of all countries in the region. The event offers to all its participants two days of cross-border experience of interesting panels, discussions, and business networking. 
